Soccer Rhode Island ODP/Academy Update

As we head into the new year, the staff is about to have its 10th week of training. Our Academy program has had 7 training sessions and our ODP program will have its 3rd training session this Sunday. Our Player Development Program, which focuses on ball mastery, is in its second session for the winter as well.

All training takes place at Wide World of Indoor Sports in North Kingstown.

Carleigh O'Keefe (Girls 2005) – Over the Thanksgiving holiday week, Carleigh traveled to Boca Raton, FL for the ODP Interregional event. She was selected as one of the top 18 players in her birth year to represent the East Region. She had a great time with the team and said the competition was strong and the weather was amazing. The East Region squad finished the week with a 2-1 record.



Upcoming Events

January 26th – ODP Full Day College Clinic, players will have two on field training sessions with coaches from Providence College, URI, JWU, Assumption College, Franklin Pierce University, Curry College, Brown University, Southern NH University, Wellesley College and several others. In between sessions on the field, players will have info sessions with the coaches to talk about the recruiting process, goal setting, and coaching/training philosophies.

February 22nd – ODP Full Day Regional Clinic, players will have two on field training session with East Regional Coaches. In between sessions on the field, players will have info sessions with the regional coaches to discuss positional roles and responsibilities, different formations, and the ODP process.

February 23^{rd} – ODP Indoor Friendly Event, players will be divided into small sided teams and have the chance to showcase themselves in front of the East Regional coaches in at least 3 games throughout the course of the day.

March 1st – PDP Session III begins its 5 Week Training. This program is offered to boys and girls with a birthyear of 2012-2006. We have training for both field players and goalkeepers.

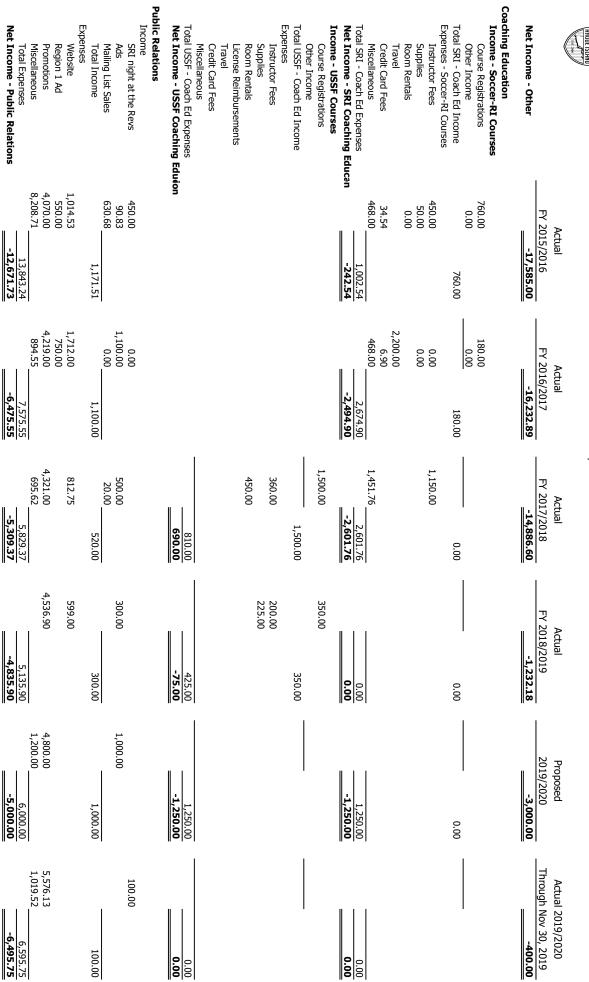
